All,

Tax Collector Service Centers will reopen to the public on June 1. Prior to opening, we are modifying a few of our procedures to ensure the safety of employees and customers as we endeavor to help stop the spread of COVID-19. Accordingly, I would appreciate your help in spreading the word to your customers and staff about the following:

- 1. Office hours will be 8:30AM until 3:30PM. Number of customers entering a service center will be limited and only the person transacting business will be permitted to enter.
- 2. The temperature of every customer will be taken before entering the building. Individuals with temperature in excess of 100 degrees will not be permitted to enter.
- 3. Customers will be required to wear a facial covering to enter the service center and while in the office.
- 4. Customers will be encouraged to continue to use online, dropbox, and mail for vehicle registration and property tax transactions.
- 5. Services will be limited which means concealed weapon original applications and driving skill tests are still suspended.
